



## YOUTH OPEN CLASS SWINE

- Registration Deadline:** All entries will be done day of show.
- Check In:** Sunday, July 14, 2024 8:30 am – 9:30 am
- Show:** Sunday, July 14, 2024 10:00 am
- Entry Fees:** Day of registration - \$25 per head. Showmanship is free
- Location:** Liberty First Credit Union Arena, 7300 Q Street, Ralston, NE 68127

## IMPORTANT

- This show is a "Blow & Go" Show. No adhesives or paints will be allowed.
- There will be **NO POWER PROVIDED AND NO WASH RACKS AVAILABLE.**
- Exhibitors will stall at their trailers.
- **Health Papers are required for out-of-state livestock.**

## SWINE GUIDELINES

FOR ADDITIONAL INFORMATION: Refer to the GENERAL & ANIMAL RULES AND REGULATIONS.

ANIMALS IDENTIFICATION: Registered Breeding Gilts are to have both ears notched with the universal ear nothing system. ID's must match with the exhibitor's paperwork.

### MARKET SWINE CHECK-IN:

- All swine will be broken up into weight groups. All breeds will show together.
- Classes will be determined by Show Management.
- Market hogs must be weighed during check-in period.

### BREEDING GILTS CHECK-IN:

- Breeding gilts must be born after January 1 of the current year.
- PUREBRED BREEDING GILTS REGISTERED – the exhibitor must have all required breeding papers for the purebred gilt to go into the class. If any paperwork is not matching up, the animals will be put in a crossbred class.

CARE & RESPONSIBILITY OF SWINE:

- ANY ANIMAL ON THE GROUNDS MUST HAVE WATER AND FEED TO ENSURE THEIR HEALTH.
- Only water may be sprayed and/or applied to the animal.
- The open Douglas County Fair will be a non-terminal show. After the show, exhibitors will take animals home.
- Animals that have active ringworm, fungus or visible warts will not be allowed entry into the Douglas County Fair. If animals are brought and found to be suspect, it is at the Show Superintendent's and Fair Official's discretion to seek advisement from a veterinarian as to possible dismissal of infected animals from the fair and show.

ENTRY LIMIT: An exhibitor is limited to exhibiting a TOTAL of FIVE hogs. Animals exhibited in showmanship must be entered in a breeding or market class.
